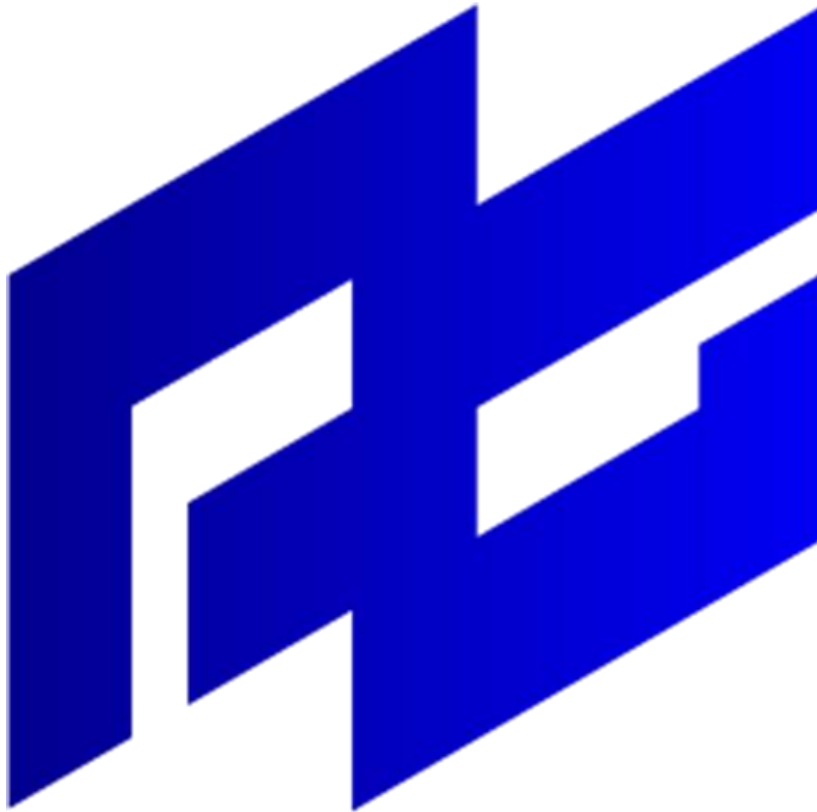




Website Terms of Use
